1. The most commonly used features Spot Healing Brush The Spot Healing Brush. The Spot Healing Brush takes up to a single pixel and changes its color to match the surrounding color. To use it: Select the target area or pixel you want to change and choose the "Spot Healing Brush" option from the Brushes toolbox and use the tool to heal the color. To change the healing area, hover over one of the edge pixels and use the cursor to select a different part of the image. To change the healing area, select the "Edge Detection" option from the toolbox or the "Adjustment" option from the "Image" menu and adjust the three sliders. The healing brush can be used for: Restoring and repairing parts of an image. Select a pixel from the image, and the healing tool will automatically select a new color for the pixel. Removing an unwanted object from an image. Select a pixel, and the healing tool will automatically remove the pixel (or the object you clicked on, if there is nothing else there). Adding a high-quality color to an image. Use the healing tool to add a color to a part of the image that does not have a color. Adding bright highlights to a photograph. If you add too much brightness, you may end up overexposing a part of the image (creating a whitish light background). The five best features for graphic designers and photographers Smudge tool The Smudge tool. The smudge tool is useful for changing the color of an image. It works much like a paintbrush. To use it: Select a pixel and hover over the tool to preview how the color will look in the selected area. Click on a pixel with the selection tool (it will be highlighted), and click on the tool to select it. Use the tool to paint the color you want, or use the cursor to make the shape of the brush change. To change the size of the brush, move the cursor while using the tool. Jay Foreman appeals a no-evidence summary judgment in favor of B.L. Wallace. In three points of error, appellant argues the court erred in granting the summary judgment. Because the record does not contain evidence of substantial and probative character on an essential element of appellant's case, we affirm the trial court's judgment. Foreman asserts Wallace committed negligence as a matter of law under a summary judgment standard. The summary judgment was properly granted under a no-evidence standard. Facts On March 15, 1990, on the day before the grand jury returned an indictment against appellant, Wallace shot and injured him in a bar fight. To support his case against Wallace, Foreman contends the "general reputation" of the bar indicated it was a "rough place." Foreman personally witnessed part of the fight and concludes that it was a fight and that Wallace was involved in the fight. However, the grand jury indicted Wallace for murder and the trial court granted Wallace a directed verdict in the murder case. Standard of Review In reviewing a no-evidence summary judgment, the appellate court must review the record in the light most favorable to the non-movant, disregarding all contrary evidence and inferences. See id.; Transportation Ins. Co. v. Moriel, 879 S.W.2d 10, 23 n. 29 (Tex.1994); see also Rattan v. Texas Dept. of Public Safety, 895 S.W.2d 752, 755 (Tex.App.®Corpus Christi 1995, n.w.h.); Tex.R.Civ.P. 166a(i). A no-evidence motion for summary judgment must specifically state the elements on which there is no evidence. See Rhone-Poulenc, Inc. v. Steel, 997 S.W.2d

You can stop the game after the point where you want to, and get an overview of the progress by running the script main.py. To get a list of all the screens that you have in your game, run the script list.py. You can run the Python script menu.py to toggle the different menus for the project. You can drag and drop the buttons on the screen, using the ctrl-click feature of the mouse. The robot features an attack, flee and defend method. The robot has the idea to attack and flee, but can defend itself with the defend button.
